It is my highest honor to welcome you to the two hundredth and third Grand Conclave of the Knights Templar of Virginia. Your presence at this conclave is a testimony to the strength, honor, and tradition of this profound fraternity.

These Fraters have finished their earthly duty and passed to hear the words, "Well done, good and faithful!" While we mourn with the night, our hope comes with the eternal dawn when we will share fellowship with our Sir Knights in the everlasting presence of the Savior.

### **Decisions**

There were no decisions issued during the previous Chivalric year.

### **Dispensations**

Between 4 May 2024 and 2 May 2025, I issued 38 dispensations. All of these dispensations were consistent with the powers vested in me as Grand Commander by the Constitutions and Statutes for the order of business in the Grand Commandery of Virginia. Each of the dispensations is attached in full to this allocution.

## **General Orders**

During the previous Chivalric year, one general order was issued. General Order, No. 1, issued 4 May 2024, is the standard general order required by the Constitutions and Statutes of Virginia with corresponding information. General Order, No. 1, was drafted and distributed in proper form and is attached, in full, at the end of this allocution.

## Grand Commander's Theme



From the outset of the year, it was my intention to further the Order through the theme of Templary & Tradition, reflecting on the past while building on the edifice of Freemasonry. My intention has been, and continues to be, to build our fraternity on the foundation of Craft Masonry, utilizing the tools, lessons, and structure of the Royal Arch, to cap the beautiful edifice of this organization with the honor of Christian knighthood through the Order of the Temple. As often said by Right Eminent Dennis Haas and many other Grand Commanders, there's no reason all Christian Masons should not be Knights Templar.

Fraters must continue to look in their history and build on the things that show what we are and stand for: this building of our Commanderies through the lessons of the York Rite Masonry. We must continue to look to the traditions of our Order and further the goals of chivalry. A tradition I brought attention to, was the laying of Corner Stones. The Knights Templar were always involved with the Grand Masters in laying of cornerstones. On July 4, 2024, I had the privilege to rededicate the cornerstone of the historic Masonic Theater in Clifton Forge with the Sir Knights of Alleghany Commandery No. 23. This year more Commanderies participated in non-asylum flag presentations, and parades.

I spent a lot of time traveling the state to Blue Lodges, and Royal Arch Chapters. At the Blue Lodges I presented programs on York Rite Masonry, more especially the Royal Arch. I explained to the brothers that they only knew one third of the story of Masonry. The completion of the history of masonry was to be found in the Royal Arch. In the Chapters I gave talks on the Christian part of masonry, and why every Christian Mason should be a Knight Templar. I explained in the Commanderies how building the York Rite was like building a house. You build a solid foundation for the house (the Blue Lodges). Then you build the walls and superstructure (The Royal Arch). Then you place the roof on the house (the Knights Templar). In layman's terms, we must seek members for our Blue Lodges and then build up our Chapters. Then we can create new Knights and strengthen our ranks.

## **Membership**

Membership in the Grand Commandery has been in the past, is now, and will continue to be our number one priority goal for this organization. As the small particles of the hourglass wane while we await the return of our Savior, the Knights of the Grand Commandery of Virginia must continue to further membership in our organization to maintain a strong foundation for future members.

While the Grand Commandery of Virginia witnessed a stellar year in new Knightings, the number of Fraters who were suspended or passed to their eternal peace has eclipsed our efforts to support membership growth in the Commonwealth. The loss in membership represents 5.5% of the total membership for the year, with death accounting for 2.5% of the total loss in members this year.

Fraters, we must be honest with ourselves and carefully examine the state of our Order. While we cannot stop the Grim Tyrant Death in his work, we can continue to converse and develop good Brothers and Companions into valiant Knights.

Our efforts to build on previous Grand Commanders' efforts to support membership are yielding good results, but we cannot lose sight of this very important battle for our existence. These warnings are not meant to be harsh or bombastic, but we must continue our crusade to keep Templary alive in Virginia.

## **Leadership**

Your Grand Commandery Officers are keenly aware of the importance of leadership in our Order. During the Chivalric year, I instructed the suspension of the Regional Leadership Conferences due to low attendance and enthusiasm. While these events are crucial for the development of constituent Commanderies, it is in the best interest of the Sir Knights and the Grand Commandery to use our time and effort in ways that will encourage participation and leadership development.

Your Grand Commandery officers are continuing to work for you. We have monthly meetings via Teams, where we discuss a wide array of topics from degree work, finances, leadership principals and the growth of our Commanderies. We make sure that all of us are going in the same direction and following our Long-Range plans. We had a Leadership Conference at MAHOVA in December with guest speaker Alan Adkins, Past Grand Master and Illustrious Sovereign Grand Inspector General of Virginia.

## **Philanthropy**

### **Knight Templar Eye Foundation**

We had another outstanding year collection \$15,000 above the average of the past five years for a total of \$76,473.27.

### **Holy Land Pilgrimage Fund**

While we wait for far happier and peaceful times in the Middle East, our Sir Knights triumphed once again with Contributions of \$15,002.00. Add to this our Fund Earnings of \$7,860.54, we had Total Receipts of \$22,862.64. We will be able to send many priests to walk where Jesus walked when the time is right.

### **KT Educational Foundation**

The Virginia Division saw accomplishments in three key areas:

1. Increased visibility of the Foundation.
2. Publicly recognized our grant recipients.
3. Grew the balance of the Fund.

The Grand Encampment continues to administer this Fund, which saw a Fund Gain of \$38,355.12.

## **State of the Grand Commandery**

Through my visits to individual Commanderies and District Visits, I am pleased to say that Virginia is on the right path. There is a spirit and willingness to do what it takes to build our Commanderies.

Our Social Media Committee has brought our Grand Commandery into our homes and for the world to see. There is a clear vision of what we are about and the direction we are traveling.

Our Trustees have implemented measures to enhance the Permanent Fund's earnings in support of the Grand Commandery of Virginia's operational and philanthropic objectives.



#### Permanent Life Membership Fund

Wells Fargo generated earning of \$26,152.61 for the year with gains of \$98,687.27 yielding a 20.57% return.

#### The General Fund

We saw produced earnings of \$16,773.04 with gains of \$28,738.71 for the year yielding a return of 7.25%.

#### E. Cary Knight Fund

Once again, Wells Fargo produced earning of \$21,590.70 and gains of \$69,924.22 for the year, yielding a return of 18.52%

Coupled with the Financial Management Team's adoption of significant business practice changes to strategically manage cash flow. They have set conditions for increased liquidity and profitability. It will be essential for the Grand Commandery of Virginia to remain dedicated to this process to ensure our plan's success.

#### Baldwin-Brown Foundation

During the Chivalric Year, the foundation received donations for 4 new pins, 35 diamond and a Commandery donation of \$150.00, totaling \$4,800.00. This is encouraging as it is an increase over the previous year.

### **Recommendations**

That the Grand Line continue their monthly Grand Line Officers Meetings. Continue building the Social Media Platform for the Grand Commandery. Remain steadfast working with our Financial Management Teams and Trustees to grow the Grand Commandery's finances. Finally continue building our Commanderies in numbers, service, and ritual performance.

**REPORT OF THE PAST GRAND COMMANDER'S COMMITTEE**  
**ON THE ALLOCATION OF THE RIGHT EMINENT GRAND COMMANDER**

To the Grand Commander and the Grand Commandery of Virginia:

Your committee thanks you for the high honor of being able to review and comment on your Allocation to the Grand Commandery, reporting on your stewardship for the 2024-2025 Chivalric Year.

Our report is as follows:

Necrology:

It is always important to the Fraternity to report the loss of all Sir Knights; however, this is not always possible. We commend you for noting the loss of forty-one (41) of our Sir Knights during the Chivalric Year. Also of note was the significant loss of:

Sir Knight William Edward Hershey, Jr., Past Grand Master of Virginia  
Sir Knight Major Green Stephenson, III, Past Grand Recorder, KTCH  
Sir Knight Arthur Wiley Mullins, Past Worthy Grand Patron, Order of the Eastern Star

Decisions:

No Official Decisions were made this Chivalric Year.

Dispensations:

Dispensations issued were noted by this Committee for their requirements of the Subordinate Commanderies to operate due to extenuating conditions concerning each Commandery.

General Orders:

General Order No. 1 – No issues were noted as this General Order is required by our Constitutions and Statutes and sets the tone for the Chivalric Year. No other General Orders were issued.

Visitations:

Your scheduling of District Official Visits continued the approximate format from previous years. The Grand Commander is to be commended for stipulating a 12:00 noon start and for requiring a Full Form Opening with rehearsal of Duties.

The Grand Commander is also to be commended for his unofficial visit to each Commandery in the State and for the number of other Masonic Bodies and Sister Jurisdictions visited.

Grand Commander's Theme:

The Grand Commander's Theme, this year, was one of the concept of York Rite Masonry through history. Once again, the Grand Commander spent much of this segment travelling around the State to spread the word. His theme also translated into Membership possibilities.

This Committee would have liked an aspect of this theme that had measurable quantities.

#### Membership:

Obviously, the Committee would have been overjoyed with a positive membership total, but sadly this was not the case.

This is the lesson to all future Grand Commanders:

Due to the average age of our Fraternity, which has come down in recent years, but still stands at 65.8 years, the Grand Commandery of Virginia loses the equivalent of a whole Commandery every year. We must find our next Commandery before we can even begin to think about adding to our numbers. This Committee would like to see the Membership Committee have an open “brainstorming” session to review new ideas and practices from the whole membership. This is all our problem.

Looking to the figures, we were also saddened by the number of Suspensions, that stand at 33. With allowance for the odd event, we believe 90% of these are due to non-payment of dues. With the loss of 12 Sir Knights from our total membership this year, some form of assistance to these 30 Sir Knights could have made all the difference!

#### Leadership:

This Committee was also saddened that the Grand Commander felt it necessary to suspend the Regional Leadership Conferences. In the past, these have been well attended and very informative. We will refer to this in our Recommendations.

We commend the Grand Commander for holding the Leadership Conference at MAHOVA in December. The guest speaker, Most Worshipful & Illustrious Alan Adkins was a wonderful addition.

It is encouraging to note that the Grand Line Officers continue monthly meetings. These are invaluable.

#### Philanthropy:

We are delighted to see that all three of our Charities, are not only alive, but doing extremely well. Congratulations are due to all concerned.

The Grand Commander is commended for adopting the Educational Foundation as the focus charity for his year. This particular charity needed attention.

#### State of the Grand Commandery of Virginia:

The Trustees of The Permanent Fund are, once again, to be highly commended, not only for their financial prudence, but for actively forcing our financial institutions to excel and meet our high expectations. Well Done to all of them!

We are pleased to see that the Social Media Committee is doing well. It would have been advantageous if the “clear vision” and “direction” had been elucidated.

With his travels, this Committee would have appreciated the Grand Commander’s assessment on the state of our ritual and the recommendations he has. This is an important and integral part of what and who we are.

Recommendations:

This Committee concurs with the Grand Commander that the Grand Line Officers Meetings continue; the Social Media platform continues and that the Trustees advance in all their good works.

For the ensuing Chivalric year, under the guidance of the Grand Commander, we would like to see the District Deputies take steps to successfully resurrect the Regional Leadership Conferences.

Also, finally see the true formation of Regional and District Degree Teams.

We congratulate the Grand Commander on his recognition of various individuals who have supported him during his Chivalric Year.

This Committee commends the Right Eminent Grand Commander for his faithful and efficient service to Virginia's Templar Masonry and welcome him into the ranks of the Past Grand Commanders, where he will continue to serve the Grand Commandery and Virginia's Fraters.



Subj: 2025 Baldwin Brown Annual Report

1. During the 2024-25 Templar year, the foundation received donations for 4 new pins, 35 diamonds, and a Commandery donation of \$150, all totaling \$4,800. This is encouraging as it is an increase over last year.
2. A total of 11 Sir Knights and one Commandery made donations:
  - a. Fredericksburg No. 1 (1)
  - b. Portsmouth No. 5 (1)
  - c. Stevenson No. 8 (6)
  - d. Jeffrey Glen Burcham No. 19 (2)
  - e. Virginia Beach No. 36 (1)
  - f. Grice No. 16
3. Balance in the fund was \$399,267.31 as of January 31, 2024.
4. Of concern to this committee is the rising cost of diamonds and its impact on this fund. Last year, the cost to set a diamond was approximately \$93. Going to lab grown diamonds, which are indistinguishable to the naked eye, would save about \$20 per diamond. Since costs will probably not go down, the revenue to the program will diminish over time. There should be consideration about raising the price of a pin to enter the program, or to add a new diamond to an existing pin.

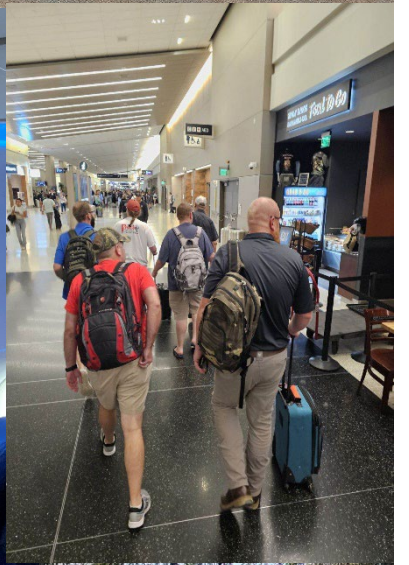

## Report of the Grand Commandery Finance Committee for 2024

Sir Knights of the Grand Commandery of Virginia,

The Deputy Grand Commander found it necessary to appoint a ProTem Finance Committee (hereafter referred to as “The Committee”) to review expenditures from 2023 and 2024 and to plan for the 2025-2026 Chivalric Year. This is their report.

This Finance Committee report includes some improvements in the accounting and financial planning for the next Chivalric Year by putting the financial records into a shared space so that all concerned with managing funds can obtain information in real time using QuickBooks online. This represents a monumental improvement and should prove extremely valuable both this year and well into the future.

After an informal review of the last years financial activities, it was determined that a formal audit was not indicated nor required under the Constitution and Statues, so an Informal Review was conducted by the ProTem Finance Committee. It is the opinion of this committee that functions to support the endeavors and mission of the Grand Commandery were financially correct.

The various committee chairmen of the Grand Commandery were solicited for their budget requirements for the upcoming Chivalric Year. With that input, The Committee, consisting of SK Clifford Gregory, SK Marion Humphreys; with the assistance of the Trustees SK J.D. Davis and SK Adam Duncan, the Grand Treasurer SK Tom Varner and Assistant Grand Treasurer SK Jason Taliaferro and the Deputy Grand Commander SK William Searcy developed a budget, which was reviewed by those Sir Knights and is presented here.

# REPORT OF THE KNIGHTS TEMPLAR EDUCATIONAL FOUNDATION

## Virginia Division

Sir Knights:

Over the past Chivalric Year, the Knights Templar Educational Foundation - Virginia Division continued to improve on the accomplishments made last year the three key areas of emphasis: 1. increase the visibility of the Foundation, 2. publicly recognize our grant recipients, 3. grow the balance of the Fund.

Many thanks go to Right Eminent Grand Commander Scott L. Fielding for adopting the Educational Foundation as the focus charity of his term. This, along with the continuation of the Regional Leadership Conferences has continued to increase the visibility of the Foundation.

For the second year in a row, we publicly recognized the grant recipients, presenting them with a certificate. This year, we did this at a Commandery event near their home, allowing more members of their family and the Sir Knights in their community to be in attendance to celebrate with them.

The balance of the fund grew by \$63,907.99, representing deposits of more than \$34,000 growth in excess of \$38,000 with withdrawals of \$8,000 and administrative fees of \$750, payable to the Grand Encampment. The Committee and Grand Commandery Trustees continue to be troubled about the frequency of reports from the Grand Encampment to the Grand Commandery as well as questions regarding the accuracy of those reports. These issues are the reason behind the proposition and two resolutions to return the Funds of the Educational Foundation back to the Grand Commandery and invest them along with the rest of the Permanent Fund.

Due to the report deadline, the Committee is not able to speak to the number of grant recipients for the upcoming 2025-26 academic year at this time. However, for a second year in a row, there was an increased number of applications for our grant program. The Sir Knights across the Commonwealth are to be commended for continuing to promote this opportunity. The grant recipients will be identified and shared publicly as soon as possible.

Our goal remains to award five grants of \$2,000 each. We plan to continue the recipient recognitions in their local community so that their family, friends and supporters can be there to celebrate with them.

The health of the Fund under the administration of the Grand Encampment continues to be strong with a balance increase of \$63,907.99 last year for an ending balance of \$393,524.28. This represents an investment gain of \$38,355.12, and deposits of \$34,302.87. Disbursements from the Fund, including grants for the 2024-25 academic year and administrative fees, totaled \$8,750.00.

This also represents a gain of \$138,565.09 since the Grand Encampment took over the administration of the Fund in February of 2020 (*initial deposit of \$254,959.19*).

We worked on further refining what we have, improving the correspondence course and on adding to the volume of resource materials available to the membership.

We continued to work with the District Education Officer for Chivalric District No. 3 to grow the supply of educational programs and resources available to enrich Conclaves and provide the Sir Knights with a more robust Chivalric experience. We confirm our disappointment that more District Education Officers were not appointed or advocated for this year. Instituting this position across our jurisdiction has been long overdue if we are to be serious about Chivalric education and about our commitment to making good men better.

It is encouraging to note the continued participation by the membership in the online correspondence course. There was a total of 32 registrations this Chivalric year.

The Membership Committee and most very active Sir Knights are heavily engaged in all aspect of York Rite Masonry, Scottish Rite Masonry and other bodies and organizations. The Committee offers the following recommendations:

2. Establish and distribute the Grand Commandery branding standard that includes ready examples of social media posts that each commandery can easily tailor for their public announcements.
3. Create a Grand Commandery Store – a place where any Sir Knight can easily buy Grand Commandery of Virginia merchandise and other Knights Templar specific items.
4. Lobby for authorization to wear the traditional Knights Templar Apron during tiled Blue Lodge meetings for special events and occasions. The apron is unique to our fraternity and an obvious conversation starter.
5. Make District, Region and Statewide Ritual Training opportunities a priority. Executing the Orders with proficiency and enthusiasm communicates the message more clearly and deeply than a shabbily performed ritual.
6. Improve the availability of ceremonial regalia. Each order has specific requirements for regalia and maintaining a full complement of regalia is the expectation. Well executed orders in full regalia, without a doubt, improves the Sir Knights' experience during the ceremony. Conferring the degrees with full regalia adds a level of drama that makes a lasting impression on new fraters and wil very likely lead to the new Sir Knight sharing his experience with others.

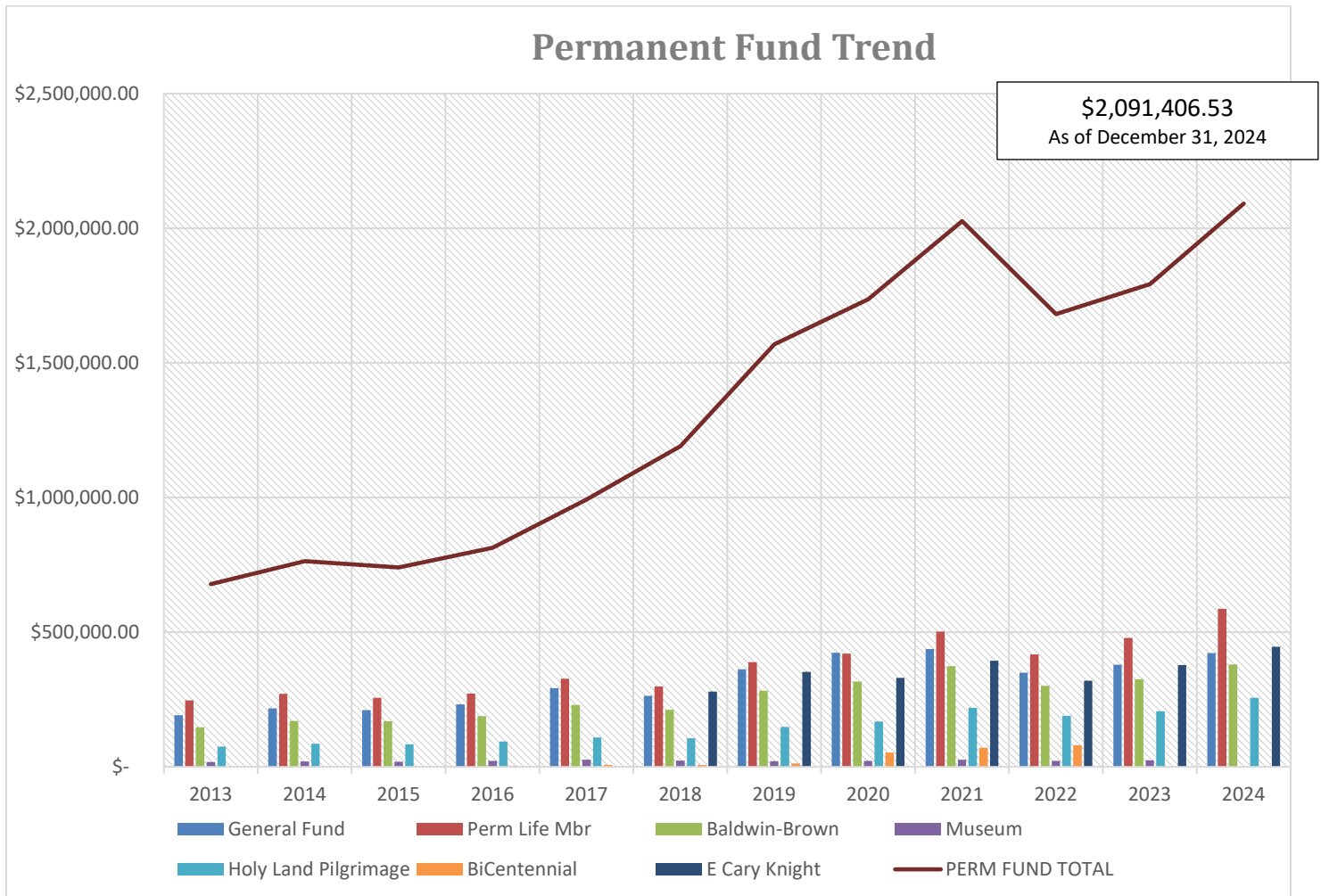

# Trustee Report on the Permanent Fund

January 1, 2024, thru December 31, 2024

To begin, a historical trend of the total investments of the Grand Commandery is provided immediately below. Upon closer inspection, the chart shows the completion of the Bi-Centennial and subsequent closing of the fund in 2022. The remaining funds were to be deposited into the Permanent Fund but were never realized. The chart also illustrates the closing of the Museum fund. Regardless, the Permanent fund appears to have recovered from the pandemic and its effects on Grand Commandery operations. The key to continued success will be obtaining consistent donations and getting them into the Permanent Fund.



Recall that in 2023 the Permanent fund was split in half and awarded to two competing financial institutions. Due to market conditions, Charles Schwab was selected to invest in cash alternatives (CDs) as a protective measure. Wells Fargo was selected to continue investing in equities. The intent was to evaluate their performances and in November of 2024 to award the Permanent fund to the best performing manager.

Schwab investors were awarded the General Fund, Baldwin-Brown Fund, and the Holy Land Pilgrimage Fund. Wells Fargo was awarded the E. Cary Knight Fund, Museum Fund, and the Permanent Life Membership Fund.



Market returns surprised investment firms with the S&P index ending the year with a 24.2% gain in 2023. The Dow Jones Industrial Average rose more than 13% that year, and the Nasdaq soared to a 43% gain. All driven by gains in big technology companies.

The Trustees made the performance decision nine months early as it was apparent that Schwab results were insufficient. In February the Trustees, with approval of the Grand Commander, made the decision to award the entirety of the Permanent Fund to Wells Fargo with Mr. David Schneeweiss as its manager. The CD's transferred over but those with long-term maturation dates were allowed to mature (December 2024) to avoid penalties. Upon maturation, those funds were then used to purchase equities.

The Grand Commandery was blessed with three Endowments during the year. A 10K restricted endowment was donated to the HLP fund. A 20K unrestricted endowment went to support the Drill Team and the budget for the year. A third endowment, also unrestricted, in the amount of \$30, 893.87 was directed by the Grand Commander to support the Education Foundation. Contemporaneous written acknowledgments were sent to each of the Endowment Trustees per IRS Substantiation and Disclosure requirements. See IRS Pub 1771 (Rev. 11-2023).

This investment year was also fraught with uncertainty. What was advertised as going to be a year of declines turned out to be one of double-digit returns. The Permanent Fund grew by 18.9% (Net of fees) resulting in an increase of \$299,546.63.

With the assistance of the Wells Fargo office personnel, the Trustees automated the distribution process. No longer will the Grand Commandery have to wait for checks from the investment firm to be sent through the Postal Service and cashed by the Grand Treasurer. Upon completion of the Constitutionally mandated action by the Financial Management Team and authorization from the Trustees, an automated transfer can be accomplished in less than 48 hours directly into the Grand Commandery Operating Account. Likewise, using mobile deposits, the Trustees can deposit checks instantly into any one of the Permanent fund accounts. Both processes were evaluated and used this year. Technology advances make it prudent for the Finance Committee to review Grand Commandery law to leverage these processes to reduce or eliminate lost checks and improve efficiency of the deposit process.

Individual fund activity and results are shown below. The charts show Grand Commandery deposits made to the Permanent fund in September. Most of the individual deposits were originally made in 2023. For every month that those deposits were not invested in the Permanent fund, the Grand Commandery lost revenue. Sadly, those opportunity losses continue and can never be recovered. These deposits represent the entirety of the 2023 calendar year's donations along with the first quarter of 2024 plus the first two months of the second quarter. This is not good business practice and violates the Generally Accepted Accounting Practices resolution previously approved.

When reviewing the individual fund activity, a few points of explanation are necessary for Wells Fargo terms. The term Equities refers to proportional ownership in stocks. Real Assets are physical assets with intrinsic worth such as real estate and natural resources and include master limited partnerships. Cash Alternatives include treasury bills, high-yield savings accounts, CDs, money market accounts, bonds and more options and money market sweeps. Fixed Income in this case consists of preferred stocks paying a set dividend amount on a scheduled basis.

**Permanent Life Membership Fund Activity.** Wells Fargo generated earnings of \$26,152.61 for the year with gains of \$98,687.27 yielding a 20.57% return. This fund's asset allocation is: 68.95% Equities, 21.45%

Real Assets, .29% Cash Alternatives, and 9.32% Fixed Income. Based on the Grand Recorder's capitation computation of \$19,028.81, the fund can pay the entire capitation for the year. The excess earnings will remain in the fund for future growth. Priority of capitation payment is to the Grand Encampment, then to the Grand Commandery, and finally to the Commanderies. This is the first year since 2022 that the fund has met its entire constitutional obligation. There were also delays in PLM deposits, creating a dilemma for the Grand Commandery. By law, Sir Knight donations are to be deposited in the PLM fund for a year before the Sir Knight is given dues relief and the Trustees pay the dues credit. If the relief is granted up front, the Grand Commandery loses money. If the benefit is delayed coinciding with the deposit and the law, a Sir Knight is liable for additional dues payments. The Financial Management Team must take immediate action to remedy this issue.

**General Fund Activity.** Originally held by Schwab, this fund was affected by the CD investments there. Wells Fargo produced earnings of \$16,773.04 with gains of \$28,738.71 for the year, yielding a 7.25% return. Asset allocation for this fund is: 73.74% Equities, 15.30% Real Assets, 1.79% Cash Alternatives, and 9.16% Fixed Income.

**Museum Fund Activity.** There have been no deposits into this fund since before 2019. In 2023, the Grand Commander partnered with the Grand Lodge of Virginia to establish a Masonic Family Museum within the York Rite Building. Earnings for the year were \$241.96. Per agreement funds were withdrawn to pay for improvement projects in the facility. In exchange, the Grand Lodge remitted our utilities obligations and rent. Once facility improvement payments were completed, residual funds were transferred to the Operating Account of the Grand Treasurer (\$3,019.15) for future building improvements and the fund was closed per resolution. Had we left this fund open, it would have been exposed to excessive fee degradation of its balance.

**Holy Land Pilgrimage Fund Activity.** Transferring from Schwab, Wells Fargo produced earnings of \$7,645.97 with gains of \$22,069.23 for the year yielding a 9.93% return. Its asset allocation is: 75.49% Equities, 13.29% Real Assets, 1.56% Cash Alternatives, and 9.67% Fixed Income. An endowment of 10K coupled with continuing donations and travel delays due to the situation in the Middle East have aided this funds growth. The last reported cost for two ministers was \$9,800.00. The \$102.00 deposit in December represents the testing of the automated deposit process using two Sir Knight dues payments with excess donated to the HLP fund. Both donations were reported to the Grand Recorder and the Chairman for their records.

**E. Cary Knight Fund Activity.** Wells Fargo produced earnings of \$21,590.70 and gains of \$69,924.22 for the year, yielding an 18.52% return. Asset allocation is: 62.71% Equities, 24.92% Real Assets, .6% Cash Alternatives, and 11.77% Fixed Income. Allocation of earnings is 70% to the budget, as needed, in the amount of \$15,113.49. Per previous resolution, this money will remain in the account increasing our growth until required for budget purposes. The HLP fund receives 5% of the earnings in the amount of \$1,079.54 This money will be transferred to the HLP account in May 2025. The remaining 25% (\$5,397.67) stays in the account for growth.

**Background 2024:**

In cooperation with, and support of, the Grand Lodge and the MAHOVA Board of Governors, the concept to expand the York Rite Building / Knight Templar Museum to a **Virginia Masonic Family Museum**, thus supporting the theme of **“Proud Member of the Virginia Masonic Family.”**

This broader family museum theme will be absorbed as a subsidiary under the Grand Lodge Allen E. Roberts Masonic Library and Museum of Virginia, Inc. but have a separate Board of Directors.

Releases the Grand Commandery from paying years of rent and utilities for space they don’t use and haven’t used in many years. The Grand Commandery will continue to have the current museum space and the Bicentennial Room with the time capsule. All other space will be offered up to other masonic organizations, approved by the Grand Lodge, as display space.

MAHOVA Board of Governors agreed to release the Grand Commandery from paying them their monthly lease from the York Rite Building (YRB), instead, to pay the monthly lease amount back into the Knight Templar Museum Fund for the 2024 year. This will build up that fund to help pay for the renovations to the building such as the HVAC system, and other museum environment improvements.

The Grand Chapter Royal Arch Masons in Virginia notified MAHOVA they would be vacating the York Rite Building effective September 1, 2024.

The Grand Commandery successfully changed the responsibility for payment of the YRB utility bill from the Grand Chapter to the Grand Commandery, Grand Recorder. The Grand Commandery and Grand Chapter will continue to co-pay the monthly utility bill through September 1, 2024.

I have received reports from the Grand Commandery Trustees that they are not receiving the monthly lease payment from the Grand Treasurer, however the Grand Recorder has stated he is sending a warrant to the Grand Treasurer to make the payments. This needs to be verified and completed.

During the 202<sup>nd</sup> Grand Stated Conclave, Proposition to Change Section 17 regarding the Museum Fund, 2024-02, passed unanimously by the voting delegates. This allows “the earnings on the current funds held for use of the York Rite Knight Templar Museum shall remain in the Museum fund to be used to fund improvements and chattels to the building. Upon agreement between the Grand Commandery and the Grand Lodge of Virginia, the Museum fund shall be closed and any residual monies shall be turned over to the new Museum, LLC.”

## **Financials:**

### **Income:**

The KT Museum Fund had a starting balance of approximately \$23, 000.

2024 monthly lease payment: \$571, annual contribution to the KT Museum Fund: \$6,852

Richmond Commandery No. 2 is scheduled to make a donation to the Museum Fund in August in the amount of \$5,000.

The Grand Commander has authorized \$10,000 to be deposited in the Museum Fund from a larger donation recently received by the Grand Commandery

### **Expenses:**

Annual Utility cost is \$6,000: split between Grand Commandery and Grand Chapter. average monthly cost to the Grand Commandery is \$300

### **Damaged Artifact:**

During the 202<sup>nd</sup> Grand Stated Conclave, The Ark of the Covenant that sits atop the time capsule in the Bicentennial Room at the Museum, was used as a visual aid, was to be carried by 4 Sir Knights, was dropped and caused to be damaged. It is my opinion we need to replace this item as attempting to repair it will not be aesthetically pleasing in a museum environment. The replacement cost will be approximately **\$1,000**.

### **Phase One Renovation:**

Inspection and design of a whole building heating, ventilation, air conditioning (HVAC) system

Fund raising campaign to help identify existing funds and pay for this new HVAC system.

Negotiated a successful agreement to cover the cost to purchase materials and labor to install 6 new Mitsubishi mini-split systems. These systems come with a warranty and a maintenance agreement.

The total cost to the Grand Commandery was **\$15,000**. This has been paid to Tom Hannifan at New River Heating and Air in Radford, VA. The additional cost was covered by our doner. Much of the labor was completed by Mike Butler, Director of Facilities, MAHOVA, and his staff.

This project is about 80% completed. Completion is expected by September 1, 2024.

### **Phase Two Renovation:**

Removal of 2<sup>nd</sup> floor, 4 glass windows, 9' x 7', and brick in both sides to match the existing brick. This cost proposal received is **\$24,900**. This project will not only assist in the operational efficiency of the new HVAC systems but will allow for additional museum wall displace space and enhanced security.

The Grand Commander has authorized an additional \$10,000 to be deposited into the Museum Fund from a donation recently received by the Trustees. With this additional funding, there should be enough funding in the museum fund to cover the cost of this project.

This project should begin in late September/October 2024.

## **2025 Projections:**

### **Phase Three Renovation:**

Interior lighting, painting, and flooring

Clean out old Grand Recorder's 1<sup>st</sup> Floor Office

### **Phase Four Renovation:**

Audio / Visual Design and Installation

Design and Build Out Recording Studio Room

## **UPDATE for the 3<sup>rd</sup> Quarter:**

Phases 1 and 2 have been completed.

The Grand Commandery paid the final utility bill as of December 31, 2024. Effective January 1, 2025, the utility bill for the YRB was transferred to MAHOVA.

The Grand Commandery should have transferred the final monthly rent payment to the Museum Fund for 2024

As of this date, I have not received confirmation that the Grand Commandery Records Office on the first floor of the YRB has been vacated. This must be completed prior to beginning renovation of the first floor.

MAHOVA completed the clean out of the 2<sup>nd</sup> floor for the items and furniture left behind by the Grand Royal Arch Chapter. The bill for the dumpster and man hours was sent directly to the GRAC Secretary for payment.

The Grand Commandery will continue to occupy the existing Knight Templar Museum on the first floor as well as the "Bicentennial Room" on the first floor.

All other space will be dedicated to, and support of, the other Grand Lodge supported bodies of Virginia masonry as agreed to in the concept paper thus supporting "Proud Member of the Virginia Masonic Family."
